

Farm and Garden Volunteer Guidelines

Thank you for volunteering with Green Village Initiative! Please read the guidelines below for each of our programs.

Guidelines for Green Village Initiative Volunteers We ask that farm and garden volunteers:

- Wear heavy-soled, closed-toe shoes, plenty of sunscreen, and farm-appropriate clothing (like long pants), and bring extra sunscreen, any snacks or lunch they may want, and a refillable water bottle.
- We suggest you wear layers in the spring and fall, as the day can start out cool and end hot.
- Please be aware that we have beehives at many of our sites; volunteers who are allergic to bees should bring an Epi-pen or appropriate medication in case they get stung.
- If your group includes youth high-school age or younger, we require a ratio of one adult chaperone for every 5 youth; the adult chaperones are required to work alongside the youth throughout the volunteer time.
- Please print out and distribute this document and the appropriate photo opt-out forms (pages 2 and 3) to your group. If any volunteer or visitor does not wish to appear in GVI photos, they should bring a signed photo opt-out form with them on the volunteer day.

Volunteer Opportunities at Green Village Initiative

Reservoir Community Farm We host volunteers at our urban farm, Reservoir Community Farm, on Saturdays, 10 a.m to 2 p.m., from April 15 to November 1. Tasks include weeding, trash pick-up, planting, turning beds, and additional gardening projects. Individual volunteers are welcome to drop by during our volunteer hours on Saturdays during the growing season. For groups of 3 or more volunteers on Saturdays, or Tuesday through Friday with advance scheduling, please contact us at farm@gogvi.org. The farm is located at 1469 Reservoir Avenue, and parking and the entrance are on Yaremich Avenue.

Community & School Gardens Green Village Initiative oversees 13 community gardens and 23 school gardens in Bridgeport.
